Pg. 4 under assignment update ANA Scope and Standards reference publication year to 2021.

Pg. 4 under competence update ANA Scope and Standards reference publication year to 2021.

Pg. 4 under delegation update ANA Scope and Standards reference publication year to 2021.

Pg. 5 under 30-7A-2 fix typo replace devises with the word devices. Pg. 7 under WVNA replace phone number with correct phone number.

Pg. 9 in paragraph 2 sentence 1 remove the words "and are included in this document as appendix C and D and insert the intext citation (West Virginia Code of Legislative Rule Title 19-03, West Virginia Code of Legislative Rule Title 19-10, West Virginia Code of Legislative Rule Title 10-2 and West Virginia Code of Legislative Rule Title 10-3).

Pg. 9 in paragraph 2 sentence 3 remove reference to Appendix C and D).

Pg. 13 last paragraph separate out and update registered nurse temporary permit language from 19-03 emergency rule as follows: An individual with a registered nurse temporary permit shall work under the direct supervision of a registered professional nurse with an unencumbered license, until the applicant has successfully passed the NCLEX-RN and a license is issued. The registered nurse temporary permits expire one hundred eighty 180 days following graduation, or until the date the applicant's licensing examination results are released to the office of the board by the National Council Licensure Examination (NCLEX-RN), whichever comes first. A registered nurse temporary permit is not renewable. The individual with a registered nurse temporary permit is subject to all provisions of West Virginia Code § 30-7-1 et. seg., and all other relevant provisions of the West Virginia Code and rules promulgated by the board. (West Virginia Code of Legislative Rule Title 19-03).

Pg. 14 first paragraph include language from active rule for 10-2 and cite rule as follows:

An applicant for licensure by examination who is a graduate of an accredited program in practical nursing, may work under the direct supervision of a registered professional nurse, licensed physician, or licensed dentist and render nursing services during the period between graduation and notification of the results of the first licensing examination. The temporary permit is valid for up to ninety (90) days from the date of graduation, to cover the period of time between graduation and notification of the results of the first licensing examination. A candidate who does not pass the practical nurse licensure examination on the first attempt shall return the temporary permit to the board office within three (3) days of receipt of the notice that he or she did not pass the examination. The board may not extend the temporary permit." (West Virginia Code of Legislative Rule Title 10-02).
