4. EXAM APPLICATION REVIEW


4. The Board reviewed the requirement in WV 19CSR3 1 c.5.B. which provides in part that an applicant graduating from a foreign nursing program must achieve a score of 50 on the Test of Spoken English (TSE). This exam is no longer offered. The Internet based exam (iBT) is offered instead. The Office of Homeland Security requires a score of 26 on this exam for health care providers. The applicant under review scored a 23. Discussion ensued. The Board determined that a score of 26 on the iBT will be accepted in place of the score of 50 on the TSE. Robin Walton made a motion that the Board accept the iBT score that meets the requirements of Homeland Security and the Visa Screen Certificate to meet the requirement of the score of 50 on the TSE which is no longer available. The second was offered by Joyce Egnor. The motion carried.

5. MISCELLANEOUS


5. There were no items under this topic.
